

PWYP-UK Consultancy Terms of Reference

ABOUT PWYP-UK

Publish What You Pay UK (PWYP UK) is a coalition of 30 UK-based NGOs united in working for a more transparent, accountable and sustainable extractive sector. The coalition has played an important role in the achievement and implementation of international mandatory extractive industry transparency standards, in strengthening disclosure under the Extractive Industries Transparency Initiative (EITI), and in working to translate extractives transparency into accountability. With these achievements, and with the accelerating climate crisis, PWYP UK is looking to build on its new strategy to identify and leverage new opportunities in the UK, particularly around climate change and a just energy transition.

ABOUT THE CONSULTANCY

PWYP-UK is fighting for a just energy transition and a more accountable extractives sector. We are actively seeking a consultant to help identify concrete opportunities for PWYP-UK's engagement, begin to mobilise existing members and other partners around them, and establish a compelling narrative and track record that can be used to attract new funding. We want someone who can help build cross movement connections between governance, climate and other groups, and need a creative thinker and passionate organiser to help us put our new strategy into action.

This role will report directly to the coalition's Trustees and could be up to full-time for up to 6 months.

IN THIS CONSULTANT ROLE, YOU WILL

- Consult members, potential partners, and other stakeholders to identify concrete opportunities for PWYP-UK to leverage its unique identity and experience in the fight for an equitable energy transition.
- Gather political intelligence, scope out potential partners, and outline a roadmap for engagement.
- With the approval of and in close consultation with Trustees, begin inputting into relevant discussions on behalf of PWYP-UK.
- Begin mobilising and engaging members and partners around key advocacy moments

and campaigning opportunities to build momentum and increase PWYP-UK's profile.

- Draft at least two funding concept notes to new donors (this could be joint fundraising opportunities with the PWYP Secretariat or other PWYP UK members, or standalone proposals for PWYP UK's work).

WHAT WE NEED FROM YOU

- An experienced advocate or campaigner with a minimum of five (5) years relevant experience.
- A deep network in the climate or good governance space (ideally both) in the UK, especially with key civil society groups, decision-makers, and donors.
- Excellent research, writing, and analytical skills.
- Strong organisation and coordination skills.
- Demonstrated experience partnering with stakeholders to implement strategic plans.

DESIRED ATTRIBUTES

- Self-starter with demonstrated initiative.
- Strategic orientation, ability to see through the noise and provide clear-eyed strategic guidance.
- Experience working with domestic-focused civil society groups in the UK.
- Strong interpersonal skills.
- Familiarity and understanding of natural resource governance and transparency issues strongly preferred.
- Some fundraising experience.
